
Blue Mountain Watershed Trust at the Ontario Land Tribunal (Again!) Huntingwood Trails East



In 2019, the developer of Huntingwood Trails applied for approval of a proposed subdivision comprised of a west and east side straddling the Silver Creek Wetlands on the south side of Highway 26. The Town had closed the file on this application originally submitted in 2011 because of lack of progress, in addition to the fact that the application was grossly environmentally problematic. The Blue Mountain Watershed Trust expressed satisfaction with the council's decision, viewing it as a victory for environmental conservation and community advocacy. However the proponent objected to the Ontario Land Tribunal. This created strong opposition from local residents and environmental organizations concerned with the proponent's Hydrological Engineering models that did not contemplate nor show the threat of overland spillage of runoff from a 100 year storm (refer to Hurricane Hazel 1954) or the Timmins Storm (1961), jeopardizing the safety of adjacent neighbourhoods.

Ultimately the applicant received approval for the western side only in 2023 with approval of the eastern side denied because of proximity to the Silver Creek Wetlands, plus access and flooding issues.

However in late 2024 the developer (Mr Edward Weisz of Toronto) again filed an application to the Town to amend the Zoning Bylaw and Official Plan to accommodate the problematic Huntingwood Trails East plan. This ridiculous Plan of Subdivision proposes a mere 62 homes east of Silver Creek. The notion of creating a road, bridge, services, and only 62 homes in a heavily wooded area while destroying PSW and Endangered Species – and accessing this through a flood plain – is obviously a plan that has zero regard for highly sensitive Natural Heritage and the surrounding existing neighbourhoods. The Town of Collingwood denied this application, and once again, the developer has appealed the Town's decision to the Ontario Land Tribunal.

The good news is that the BMWT has acquired Party Status at the pending OLT hearing, despite the strenuous objections of the proponent. This is likely a costly 6-week hearing where lawyers and experts testify. Our Party Status enables us to hire an expert Hydrological Engineer to convince the Tribunal that an enhanced Hydrodynamic Model (2D HEC-RAS) must be created by the developer to more accurately depict flooding conditions and spillage within both the development and Silver Creek Wetland Complex.

To date, there have been 3 Case Management Conferences – these are the preliminary OLT led meetings with the participants whose purpose is to find those issues for which the parties can agree. The outstanding issues will form the basis for the actual OLT Hearing. The need for multiple CMC's indicates how far the parties are apart – this is a good sign as the Town does not see much good to the development.

The Huntingwood Trails East mocks the Provincial Planning Statement that prohibits development in a flood plain. We all now recognize that today fewer green spaces, wetlands, and pristine waterways exist than in the recent past, and we must protect them, particularly in light of climate change and rapidly declining biodiversity.

Protection of the Silver Creek and surrounding wetlands is the foundation of the Blue Mountain Watershed Trust, and we will continue to strenuously take action on these and other threatening developments.
